## STUDENT DRIVING / PARKING REGULATIONS

**Violation of any regulation may result in immediate revocation of parking privileges, arrest, issuing of citation(s) and/or towing of your vehicle at your own expense.**

1. **YOU MUST DISPLAY YOUR PERMIT IN YOUR WINDSHIELD.** Failure to do so will result in your vehicle being ticketed and/or TOWED at your expense.
2. The parking tag may only be used for authorized vehicles whose license numbers are listed on the application. The parking tag may **NOT** be duplicated, or loaned to other students. **CARPOOLERS** must have **ALL** vehicles registered **AND** parent signatures from all participants.
3. This parking permit may be **REVOKED** and confiscated by the Park District or any Park District Police Officer if the user violates any state or local traffic law or other ordinance.
4. This permit allows you to park in the **STUDENT PERMIT** parking areas **ONLY**. You must obey all other posted traffic and parking control signs and devices.
5. Students use the parking lots at their own risk! The Park District is not responsible for any damage, theft, injury or death arising from driving to or from school or driving/parking on Park District property.
6. **REFUNDS OR REPLACEMENTS** – The Park District will only replace lost/stolen tags after a complete report has been filed with the Park District Police. Filing a false police report is a crime and offenders will be prosecuted. Replacement tags are \$15 and the original tag will be voided in our database. **NO REFUNDS WILL BE ISSUED.**
7. **KEEP YOUR TAG SECURE! LOCK YOUR CAR AT ALL TIMES. REPORT ALL LOST/STOLEN TAGS TO PARK POLICE.**

### WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this language carefully and be aware that in consideration for issuing of a parking permit and parking privileges, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this parking permit.

I recognize and acknowledge that there are certain risks of physical injury to students exercising parking permit privileges, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of travel to or from or parking on Park District property. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of said parking pass privileges against the Naperville Park District, including its officials, agents, volunteers and employees.
